MATTERS ARISING

715/13/14 Neighbourhood Planning - Burneside (Minutes 619 and 669/13/14)

- SLDC had published on its website comments made by Burneside Parish Council about Kendal Town Council in relation to boundary issues. The Town Council had made an official complaint to SLDC that its response to those comments, in a letter of 29th January 2014, had not appeared on the SLDC website. Subsequent to the complaint, SLDC had now published the Town Council's letter on its website. A letter of confirmation had been received from Alastair McNeill, SLDC Development Plans Manager, and this was presented to the Committee. SLDC had also advised that Burneside Parish Council has suspended its application for Neighbourhood area status until consideration is complete of its concerns relating to the capacity of the SLDC Cabinet to make a decision on this matter.

716/13/14 LOCAL DEVELOPMENT PLAN UPDATE

The Town Council had been informed of the official timetable for the consultation on Development Briefs (Draft Outline Proposals – January 2014) and had been asked to submit comments, which had been done in a letter dated 4th February 2014. In response to a query in that letter, SLDC had advised that no sites in Kendal are expected to be progressed through the "fast track" process described in Paragraph 1.10 of the consultation document. However, no other KTC questions/comments have been addressed so far.

717/13/14 CUMBRIA ASSOCIATION OF LOCAL COUNCILS (CALC) – PLANNING TRAINING

The Town Clerk had asked if anyone on the Planning Committee was interested in taking advantage of this training opportunity.

718/13/14 KENDAL CENTRAL PEDESTRIANISED AREA – MAKING THE EXPERIMENTAL TRAFFIC REGULATION ORDER 2012 PERMANENT

Cumbria County Council has indicated that, following the successful twelve-month trial of the Experimental Traffic Regulation Order 2012, it is proposed to impose the following restrictions on a permanent basis.

- No loading or unloading between the hours of 11am 4pm within the pedestrian zone; which comprises of the entire lengths of Finkle Street, Market Place and Branthwaite Brow, the length of Stricklandgate between Library Road and Finkle Street and the length of Highgate between Finkle Street and Allhallows Lane / Lowther Street
- Limited stay parking restrictions of 3 hours, no return within 3 hours to apply to the three disabled parking bays on Finkle Street and the four disabled parking bays on the Market Place, with the exception of Market Day.

Details of the proposals were presented in a plan.

The County Council was seeking comments and/or objections by Friday, 21st February 2014, therefore no time was available to refer this to the proper service Committee (Environment and Highways).

While no objections were raised to the proposals, it was felt that it would be appropriate to refer the matter to the meeting of the Management Committee to be held later in the evening, because there were relevant items on the agenda for that meeting.

RESOLVED that the matter be referred to the Management Committee for consideration/comment.

Members considered Planning Applications submitted for consultation purposes by the local planning authority, South Lakeland District Council.
