

## P142/2023 Planning Process and Issues

The Chair and Town Clerk drew Members' attention to a recent advert relating to commercial development land east of Burton Road, Kendal, seeking offers in excess of £1. The

Committee was reminded that the Town Council had, last year, made a submission in relation to the current Land Allocation consultation, and that this had included an indication of the Council's opposition to development on this particular land. The Town Council had made it clear that it wished for this land to remain a green belt between Oxenholme and Kendal, alongside the railway line, and for it to remain a green space with, for example, parkland or low-level sport activity.

## P143/2023 Kendal Town Council Flood Relief Scheme Working Group

Cllr J Cornthwaite, Chair of the Kendal Town Council Flood Relief Scheme Working Group, reported that the Group had met on 23 January 2024 in the new Flood Hub at Beezon Road Industrial Estate. Discussed had been a couple of recent near miss high river levels. The Environment Agency were due to discuss with Housing Association residents who owned their properties how to assess their own property level. Also discussed had been the fountain on Aynam Road and its relocation to Abbot Hall. The Environment Agency was also now actively seeking new or additional flood storage areas. Cllr Cornthwaite lastly referred to the opening of the new glass panels at Gooseholme, at which the Area Flood Manager for Cumbria and Lancashire, Richard Knight, who was in charge of the scheme, had been present. Notes of the meeting would be included within the agenda for the next meeting of the Planning Committee. The next meeting of the Group would be due to take place on 21 March 2024.

In response to a query, the Town Clerk advised Members that the Environment Agency, who owned and controlled the floodgates, had explained that those gates which had already been installed could not be used until the scheme was complete in its entirety, as closing them at this stage could have a negative impact on other areas.

## KFRS 12/2023 Apologies

Apologies were received and accepted from Cllr H Ladhams (for the first part of the meeting) and D Rathbone

## KFRS 13/2023 Minutes of the Previous Meetings

The minutes of the previous meeting were considered and accepted as a true record.

### KFRS 14/2023 Environment Agency Report

It was noted that Richard Knight (senior manager at EA) was not able to attend, but would do so at a later date).

EA reported that only a single property in the Kent catchment was believed to have been flooded in Storms Isha and Jocelyn. This was not in Kendal and property-level protection was being discussed with the occupant.

Tom welcomed members to the new hub at Unit 2b Beezon Road. Signage is anticipated shortly.

Alison Kirkpatrick gave the update report. F4 and Stock Beck pumping station were making good progress. Diversions were nearing completion, the chamber was dug and the new building for the pump station was due to start very soon. Generators were about to be replaced by mains connectivity. Glass panels on F1 below Stramongate had been installed, and noticeboards updated. Border TV would do interviews on 2 February.

At G2 Waterside, where piling work had hit boulders, a new rig had been installed and there was optimism about the results, though noise and vibration levels would have to be monitored.

There was some discussion about gate operation during Isha/Jocelyn, but EA confirmed that it was a condition of the scheme's planning that no new elements would be put in operation until the scheme was complete, to lessen the potential impact on down/across stream areas. EA would reinforce their comms message with residents and SLH. It was noted that W&FC had mended the coping stones on Miller Bridge and removed the ivy and other vegetation from the railings, so their engineers could more effectively inspect their part of the riverbank and bridge that was not in the scheme.

On Aynam Road, G1, G3 and H1, ENWL diversions and BT work would start in the spring.

F3 New Road was due to Planning in February 2024, for commencing May 24.

Construction work across the scheme would now slip into completion in 2026, with most completed in 2025 and only landscaping and de-mobbing remaining.

Railings at Nether Hall should be completed shortly, after failing initial inspection, so the red and white barriers can be removed.

Upstream, a new design for the Stock Beck catchment drain is now agreed. It will be a covered drain with a network of feeders and a headwall system to protect Sandylands from extreme run off. Technical design will be completed in 2024-25, in consultation with landowners. Construction will follow in 2026/27. Fowl Ing Lane won't be used as construction access.

Burneside, Staveley and Ings survey work will continue through 2024, with design expected the following year. Construction is planned for 2026. Ongoing survey work in the catchments of the Kent, Sprint and Mint, along with landowner discussions is anticipated to bring forward new options for upstream floodwater storage.

Several initiatives are looking at landscape recovery projects in the upper Kent, which will include natural flood management elements as well as increasing biodiversity.

At Mintsfeet, several stretches of new footpath were washed out by Isha/Jocelyn and will require reinstatement. Some of the designs will also be altered to improve their robustness.

Discussion about the emphasis on upstream measures included publicity, timescales and relative security.

### KFRS 15/2023 KTC Issues

There was a query about the progress of the relocation of the Aynam Road fountain. Graham Harrison reported that this was currently with the Civic Society to progress through Planning.

Self-seeding vegetation on much of the Aynam Road bank was a matter for Westmorland and Furness to assess as it was their land.

The 'missing link' footpath on Waterside would be picked up in the LCWIP related work on Kendal 'Riverside South'.

The EA would continue to log complaints about the noise of the generators on castle Crescent, but anticipated that this issue would reduce dramatically with the use of mains electric.

The Town Clerk would share contact details for the Westmorland and Furness Countryside Access team with Tom.
