- 484/19/20 MINUTES OF THE MEETING HELD ON 22ND JULY 2019**
- The Chairman presented the minutes of the meeting held on 22<sup>nd</sup> July 2019, which had been approved by full Council on 2<sup>nd</sup> September 2019.
- Councillors Cook and Dunlop had been present at that meeting and approved the minutes as a correct record.

- 486/19/20 EXTERNAL AUDITOR'S REPORT**
- The Treasurer advised that the external auditor's report confirmed that KTC have complied with Proper Practices.
- A note raised in respect of non-compliance with Regulation 15 of the Accounts and Audit Regulations 2015 was highlighted. The Treasurer explained that the regulation had been complied with and the note referred to the way in which it had been reported. She has spoken to the external auditors in this respect and a note will be made for next year.

- 487/19/20 BUDGETARY CONTROL STATEMENT – SIX MONTHS ENDED 30<sup>TH</sup> SEPTEMBER 2019**

The Treasurer presented the Budgetary Control Statement for the first half of the financial year.

A further instalment of CIL (Community Infrastructure Levy) income has been received from SLDC, amounting to £1,188. The Treasurer advised that the amount of CIL income received this financial year will be less than last year. It is not budgeted for as the amount is unknown.

Expenditure to 30<sup>th</sup> September is within the profiled budget for the year to date. There has been no use of the contingency provision to date.

**2020/21 BUDGET**

(a) Budget Proposals

Committee considered the budget requirements for 2020/21. Councillor Cook proposed this be accepted without change. Councillor R Hogg seconded the proposal and it was carried unanimously.

(b) Draft Reserves Policy 2020/21

The Treasurer advised that one change is suggested to the existing policy relating to the election reserve. The proposal is to increase the range from £10,000 to £16,000 in line with latest costs. Councillor R Hogg proposed that Council be recommended to approve the increase. This was seconded by Councillor Cook and carried unanimously.

**RECOMMENDATION**

That Council approve the increase of the election reserve range from £10,000 to £16,000.

(c) Draft Investment Policy 2020/21

Committee were asked to consider this policy. Councillor Cook proposed that it be accepted without change. This was seconded by Councillor R Hogg and carried unanimously.

**GRANT APPLICATIONS 2019/20**

The Treasurer advised that a balance of £11,760 remained in the grants budget of £41,000 for the current year. The grant applications were considered and the following recommendations were made:

**10<sup>th</sup> Kendal Scouts**

Request of £500 towards camping equipment. Committee recommended that a grant for the full amount be awarded.

**RECOMMENDATION** That a grant for the full amount requested of £500 be awarded.

**The Bryce Institute, Burneside**

Request of £5,000 to help fund replacement windows at Burneside Village Hall. Committee recommended that no grant be awarded as the Institute is outside Kendal. Treasurer to make contact and forward a list of other possible funders.

**RECOMMENDATION** That no grant be awarded.

**South Cumbria Breastfeeding Support**

Request for £5,000 towards room rent, costs of volunteer training and fees relating to the Kendal Mums group. Committee recommended that a grant of £1,000 be awarded.

**RECOMMENDATION** That a grant of £1,000 be awarded.

**The Birchall Trust**

Request for £8,750 towards core costs towards providing one to one counselling and therapy sessions for adults and children in Kendal affected by sexual abuse. Committee recommended that a grant of £750 be awarded. The decision was made based on the large size of the organisation.

**GRANT APPLICATIONS 2020/21**

**HR AND HEALTH AND SAFETY CONTRACT**

Committee were informed that the 3 year contract with Moorepay has recently expired. There will be a price increase from £1,700 to £2,100 per year, however there is the opportunity to re-tender next year. The Treasurer advised that KTC do utilise the service and it has been satisfactory.

Following discussion it was agreed that the Treasurer will identify 3/4 alternative companies which can be invited to tender for next year.

**493/19/20 REPORT FROM DOWKER BINDLOSS**

The Treasurer presented a report. Councillor Cook provided background information and explained that Cumbria Community Foundation handle the matter on behalf of KTC, with the proviso that monies are ring-fenced for applications which benefit the people of Kendal. He summarised the report as follows:

- 9 projects have been supported by Dowker Bindloss.
- £1,000 was granted to Manna House.
- A total of £5,134 has been granted.

It was noted that only the interest on the capital sum held can be granted.

Committee noted the report.

**494/19/20 SCHOOLS OF SCIENCE AND ART CHARITY**

**(a) Application for Assistance – Sarah Neill**

Members were asked to consider an application received from Sarah Neill for £3,000. The applicant, a lecturer at Kendal College and marine biologist, has been selected to join a team of talented sea-women from around the globe on a Sedna Epic Expedition to the High Arctic in November 2020. She is the only woman from the UK chosen to attend the 2020 expedition. The total cost of the project is £6,500, with funds received to date of £830.

The Treasurer advised that the Charity currently holds accumulated funds of approximately £16,000. It was previously agreed that capital is to remain at £13,360 and money has been earmarked for the Artsmark initiative. This leaves an available sum left to spend of £1,230.

In her application Sarah Neill stated that the skills and experience she gains from this opportunity would enable her to deliver more enriching lessons to students on both BTEC and degree classes.

Following a general discussion Councillor Dunlop proposed that funding of £500 be awarded. This was seconded by Councillor R Hogg and carried unanimously. Members agreed that the applicant should be requested to submit a report following completion of the expedition.

**RECOMMENDATION** That funding of £500 be awarded to Sarah Neill from the Schools of Science and Art Charity. Applicant to be requested to submit a report following completion of the expedition.

**(b) Cumbria Building Society Investment**

The Treasurer advised that the interest rate for the 30 day notice account would be increasing from 0.9% to 1%. This was noted by Committee.
