

E31/21/22 Minutes of the Previous Meeting

The Council received the minutes of the Committee meeting held on 13 September 2021. The Chair asked if there was any update on the production of a bio-diversity policy. The Clerk reported that this was still work in progress.

Resolved: To commend them as a true record.

E32/21/22 E & H Budget and current spend to date

The Committee considered the budget for the current year and noted the separation of development fund projects and Environment and highways core projects.

Resolved: To note the report

E33/21/22 Project Updates

The Project Manager set out a written report on project updates and Committee members raised various questions.

Kirkbarrow Connections Project.

Councillors asked if this project is developing at pace or moving more slowly. The Clerk reported that Cumbria County Council are going to carry out some remedial work in April 2022 and there are ongoing surveys taking place. Concern was expressed about legal progress on the purchase of additional land.

Ivy Screening

The Project Manager reported that further installation around Longpool had been well received. It was felt some signage indicating the work has been carried out by the Town Council should be installed.

Pump Track

Land Allocation responses are required from SLDC. It was agreed to take this forward with local District Councillors.

It was felt reporting project updates would benefit from the addition of target dates and/or milestones.

Resolved: The Clerk and/or Project Manager will update the Project Update Report to include milestones and costing information.

Resolved: The Project Manager will arrange for Kendal Town Council signage acknowledging the installation of ivy screening at Longpool and Blackhall Road.

E34/21/22 Gooseholme Anti-Social Behaviour

Councillors received an overview report. It was suggested to review the Safer by Design Audit via an informal meeting with Councillors and the author of the audit, to work up more detailed proposals. Members would be Councillors Cornthwaite, Archibald, Dunlop, Evans plus the Clerk and Project Officer. It was also suggested to invite the relevant resident who raised this at last meeting. The remit of the working group would be to identify the salient points and bring back a report to next E&H meeting.

Councillor Evans promoted new youth activities at Castle Street Centre via Kendal Youth Zone.

The provision of a public toilet was discussed. Clerk reported that the Police have the view that they would not support such a provision as this would exacerbate the anti-social behaviour as outlined in the report. Other proposals to be discussed with working group.

Resolved: To set up working group consisting of Councillors Cornthwaite, Archibald, Dunlop and Evans plus the Clerk and Project Manager. The working group will decide if a wider membership is needed. The remit of the working group is to disseminate the Safer by Design Audit and the paper circulated by the Project Manager for this agenda and present proposals to the next E&H meeting.

E35/21/22 Fellside Play Provision

The Committee considered the report and the opportunity to work with the Fellside Forum regarding enhancements to Serpentine Woods. Councillors agreed the Town Council can support the maintenance of the Alphabet Trail. The plans of the Kendal Civic Society to create a new entrance from M&S into Nobles Rest and the possibility of this area being developed as a natural play area for younger children was discussed. The need to enhance Bowling Fell around the Monument was also highlighted. As per the report, it was highlighted that access issues make the area unsuitable for play provision.

It was noted that the idea of a play area in Nobles Rest had been rejected by SLDC, nevertheless it was felt helpful to revisit this and explore opportunities for natural play areas.

<u>Resolved</u>: To continue developing natural play ideas in partnership with Fellside Forum and Kendal Conservation Volunteers and create a maintenance support budget for the Alphabet Trail.

Resolved: To approach SLDC re possibility of play provision on Nobles Rest in conjunction with Civic Society entrance plans.

<u>Resolved</u>: To consider a Bowling Fell improvement project in the next financial year's budget.

E36/21/22 Natural Kendal

The Chair reported on the formation of this working group. The committee received a presentation at the last meeting about Wild Kendal which is now being renamed Natural Kendal. This proposal seeks to fund an initial piece of research work to help kick start this important development.

Resolved: To approve the proposal to fund baseline research of ten days at a cost of £3,000

E37/21/22 Lancaster Canal Regeneration Project (LCRP)

The Committee considered the attached report. The Committee required clarification on costs and suggested ideas on different barriers at the entrance to the cycle path to create a bike friendly entrance. The Committee felt there could be better use of the historic £10,000 LCRP grant on improved signage for cyclists once decisions have been made on a definitive cycle track through Kendal via the LCWIP process

Resolved: To revert to LCRP for cost clarification.

E38/21/22 Municipal Composting

The Project Manager reported on a request from the Allotments Committee requesting £145 for composting materials for the allotment at Castle Haggs

Resolved: To allocate £145 to trial a muncipal composting site at Castle Haggs.

E39/21/22 Biodiversity Budget

It was clarified that £10,400 remains in the budget. It was felt that the research being carried out by Natural Kendal would provide an ideal source of ideas and connections to community groups who can benefit from this funding.

<u>Resolved</u>: That the Clerk and Project Officer report on possible ideas for future funding mindful of Natural Kendal's research.

E40/21/22 Cycle Racks at Longpool

The local shop owner has asked the Town Council to consider the installation of a cycle rack to help mitigate current bike parking arrangements.

Resolved: To further investigate an exact location with the shop owner and report back to the Committee.

E41/21/22 Budget 2022-23

The Clerk presented a draft budget for 2022-23 and answered questions from Councillors. Councillors felt the budget totals were not necessarily aligned with the wider aspirations of the E&H Committee

<u>Resolved</u>: To defer decisions on budget approval to a further single agenda working group meeting that engages with some of the wider aspirations of the Committee.

Action Plan Costings 2022-23

Green Spaces Improvements (£23,000)

This is an additional budget line in the Development Action Plan to meet the proposals from the Committee

- Bowling Fell Improvement Project stage one, feasibility and plan £7,000
- Serpentine Woods Alphabet Trail Maintenance Fund £1,000 per year x3yrs
- Fellside Play Provision £5,000
- Valley Drive Dark Skies Lighting Scheme £10,000

Public Realm Enhancements (£10,000)

This is a relatively straightforward delivery of an extension of the ivy screening from Longpool and Blackhall Road.

- Ivy screening expansion on to Windermere Road £10,000
- Windermere Road painting improvements tbc

Cycling and Walking (£36,000)

This puts some more concrete proposals behind the existing ambition to develop Active Travel initiatives.

- Footpath Quality audit £7,000
- Kirkbarrow Footpath improvement Project £15,000
- Signage improvements for footpath and cycleways £4,000
- Towpath Trail entrance improvements £10,000 (insert cost clarification)

Climate Change (£17,000)

Bringing forward the Council's Climate Change imperative and developing specific actions from the Jury Recommendations.

- Town Centre Recommendations Hub (in partnership with WIW and Repair Cafe) £10,000 per year x3yrs
- Solar Campaign (to target solar potentials highlighted in the audit) £5,000
- Online Inspiration hub and associated projects £2,000

Biodiversity (£11,000)

Developing the Council's commitment to nature recovery, this may include funding for the Natural Kendal initiative.

- Dark Skies Campaign (to target polluters highlighted in the audit) £5,000
- Second round of Biodiversity Grants £6,000

Additional Recommendations

The following budget considerations do not align specifically with the E&H Committee's current budget competences, but may be considered as additional observations/recommendations for consideration by the Management Committee, as appropriate.

Increased Delivery Resources (£25,000)

It is recognised that delivery of the E&H Committee's ambitious action plan proposals may require additional staffing capacity. This is estimated at around FTE 0.65, approx. 24 hours per week.

• E&H delivery project officer support – in the region of £25,000, including salary and overhead.

Natural Flood Management (£15,000)

To enable Paul Quinn (Newcastle University) to carry out an evaluated study of his proposal for an NFM + design in the upper reaches of the Kentmere valley, to complement existing EA work planned lower down the valley. Cllr Chris Rowley has prepared a briefing on this, which will be circulated separately to members of E&H and Planning.

Following introductions the group discussed inviting the following additional members:

Cllr Peter Thornton (to strengthen approach to CCC)
Karen Gea (to strengthen links to active travel group)
A representative of Kendal Futures Transport Group

CCC Current Position

The group discussed the County Council's current position and discussed various approaches to encourage a sense of emergency and challenge standard approaches. The group agreed the following questions to be sent to CCC in advance of the next full partner meeting:

- KTC understand CCC current procedure led approach to installing 20mph but is it statutory and if guidance only, is it fit for purpose given the Climate Emergency?
- Is the preferred tube approach considered necessary because CCC favour a phased approach? Does a phased approach require a greater level of data?
- Markides have confirmed many towns use phone data to confirm average speeds, we feel our data is adequate but accept that for a small number of specific roads additional data may be required. Is the collection of additional data DFT guidance or statutory?
- Kendal Town Council's position is to progress 20mph in Kendal regardless of Northern Relief Road Developments and we require a guarantee that CCC share this position.
- Kendal Town Councils preferred approach remains installing a town wide 20mph speed limit via signage initially with reconfiguration considerations after the limit has been introduced.
- Examples from similar towns show signage only approaches can be achieved for less that £250,000. Can CCC provide a costed breakdown of what they would need to implement a signage only scheme?

- Kendal Town Council view arterial roads within the Kendal parish boundary as residential and views the differentiation between arterial and residential as unhelpful and exclusive rather than inclusive for all residents.
- LCWIP national guidance states that 20mph should be considered as a supportive action. Can CCC explain why 20mph has been omitted from Kendal's LCWIP considering that LCWIP's determine future funding for the area?
- CCC have stated that a 10% response rate would be required for a 20mph consultation. This is way above the response rate of any other similar consultation carried out by CCC, why is this the case?

Next Steps

In addition to sending the above the group discussed the following milestones:

- 1. Continue current dialogue and momentum with CCC Highways via questions above and subsequent meeting.
- 2. Prepare proposal for shadow authority to consider in May 2023, proposal to include
 - Demonstrable public support (including 2015 survey results) and letters of support. This approach is in line with national 20's plenty campaign advice which recommends Highway scheme approval first before raising public expectations)
 - b. Detailed costs
 - c. Request for 2023/24 budget allocation

Kirkbarrow Connections Project


CCC Public Rights of way team are responsible for unsurfaced footpaths if designated as Public Right of Way (PROW).

CCC Highways team are responsible for surfaced footpaths.










6. Echo Barn Hill to The Adventure

Summary: The committee are asked to approve four proposals to improve signage, railings, green space access and a bus stop.

Current budget £4000

Remaining budget if each proposal is approved £700

1. Woolpack Yard

Background

The new Woolpack Yard sign is in place. Elephant Yard Managers have asked Kendal Town Council to consider adding the logo of a new business Kaw Kaw. Kaw Kaw have agreed a long term lease and Elephant Yard feel small independents should be advertised instead of Boots which as a strong High Street presence.

Proposal

Approve £100 to replace the Boots vinyl with the Kaw Kaw café logo.

2. Signage Improvements SLDC Transfer

Background

In July 2021 a partnership project to improve signage within Kendal was proposed to SLDC. Officers did not want to progress and recommended that Kendal Town Council logged individual cases via the customer connect program as an alternative approach. Kendal Town Council promoted this service in the December newsletter and SLDC received numerous requests for signage improvements. SLDC Officers subsequently have asked to work with Kendal Town Council on a partnership improvement program as previously suggested.

Proposal

Transfer £3000 to SLDC to carry out signage improvements highlighted on the KTC audit. SLDC have confirmed an average costs of £80 per sign, this funding would unlock the improvements of 37 signs which could be prioritised according to impact and or footfall.

3. Railings Improvements

Background



Councillor Giles Archibald has highlighted the following improvements based on resident requests.

Proposal

- 2.a Repaint Thorney Hill entrance railings £200
- **2.b** Install a hand rail at Triangle Community Garden costs to be covered by Fellside Forum, the request is for Kendal Town Council to oversee the installation.
- **2.c** Install a hand rail at Fountain Brow Permission required from Cumbria County Council, Councillors to consider progressing via the 2023/24 budget considering current SLDC signage opportunity and CCC permission timescales.

4. Bus Stop Improvements

Background

Cumbria County Council have approached Kendal Town Council to consider providing seating at the bus stop serving the Westmorland General Hospital. CCC were made aware of the lack of provision by a bus service user who visits the hospital regularly and it would benefit many residents who frequently use the bus to access the hospital. CCC have funding to cover the costs of the purchase and installation of new seating.

Proposal

Approve an application to the Bus Users Funding and the adoption and ongoing maintenance of new seating at the Hospital bus stop.

Current budget, £4855

Remaining budget if each proposal is approved, £3855

1. New Composting Bins

Background

This committee allocated £5,000 towards improving composting facilities in Kendal following the Municipal Composting report prepared by SLACC.

At the previous meeting, approval was given to install a compost bin at Castle Haggs allotment. This has been installed and well received.

SLDC are supportive of improving the opportunities to compost leaf litter and old plants and have given permission to install bins at Nobles Rest and the Cemetery near the allotments. The Townscape Manager is a Master Composter and will lead sessions with Continental and the Friends of Group to ensure the bins are utilised as intended. Discreet locations have been agreed for both sites. The resulting compost will be used for Kenda's Civic planting.

Proposal

Approve spending of £1,000 to install composting bins at Nobles Rest and the cemetery.
